Campaigning picks up in 13 Maharashtra Lok Sabha constituencies

Mumbai, May 15 (UNI) : The din and bustle of election campaigning is gradually reaching a crescendo as the remaining 13 Maharashtra constituencies including those in this financial capital and the adjacent districts slated to vote in the fifth phase of the Lok Sabha elections on May 20.

So far, 35 out of the 48 seats in the state have gone to the hustings.

Apart from the half a dozen seats in the western metropolis - Mumbai South, Mumbai North, Mumbai North West, Mumbai North East, Mumbai North Central and Mumbai South Central - the poll caravan will also move to Thane, Bhiwandi, Kalyan, Palghar, Nashik, Dindori and Dhule Monday next.

Altogether 264 candidates are in the fray for the 13 constituencies including union ministers Piyush Goel (BJP-Mumbai North), Bharti Pawar (BJP-

Dindori) and Kapil Patil (BJP, Bhiwandi), former union minister Dr Subhash Bhamre (BJP-Dhule), Arvind Sawant (UBT-Mumbai South), Anil Desai (UBT - Mumbai North Central), Varsha Gaikwad (Congress-Mumbai North Central), Rajan Vichare (UBT-Thane), Ravindra Vaikar (Shinde Sena-Mumbai North West). Prominent lawyer Ujjwal Nikam (BJP-Mumbai North Central) and Shobha Bachav (Congress-Dhule).

With the campaigning picking up, allegations and counter-allegations are flying thick and fast between the main contenders Mahayuti (Grand Alliance comprising BJP, Shinde Sena and the Ajit Pawar-led NCP group - all part of the NDA bloc) and Maha Vikas Agadhi (comprising Congress, Uddhav Thackeray led UBT and the Sharad Pawar-headed NCP-SCP - all part of the INDIA bloc).

Prakash Ambedkar's Vanchit Bahujan Agadhi and the AIMM, as well as some of the smaller parties, have put up candidates in some of the constituencies.

With only three days left for the campaigning to end on May 18, Prime Minister Narendra Modi is addressing election meetings in Pimpalgaon and Kalyan, besides holding a road show in the evening in the Ghatkopar area of suburban Mumbai.

On May 17, Modi will address a rally with top Mahayuti leaders including Chief Minister Eknath Shinde and Deputy Chief Ministers Devendra Fadnis and Ajit Pawar in Mumbai.

On the other hand, UBT chief Uddhav Thackeray is busy campaigning in various areas in Mumbai and its suburbs in support of MVA aspirants. On Wednesday evening,

Thackeray is slated to address a meeting in the Nashik constituency in support of his party nominee Rajabhau Waje.

The grand old man of Maharashtra politics and NCP-SCP chief Sharad Pawar is also attending an election rally in Wani of Dindori constituency in support of his party nominee Bhaskar Bhagare.

Chief Minister Eknath Shinde and his Deputy Devendra Fadnis have also lined up meetings in several constituencies.

Among other prominent leaders, MNS Chief Raj Thackeray, NCP-SCP leader Jayant Patil, MPCC president Nana Patole, UBT leader Aditya Thackeray, VBA chief Prakash Ambedkar are among the other star campaigners.

More than average 60 percent polling was recorded during the last four phases of election in the state.

Over 1600 water tankers providing drinking water in 7 dists

Chhatrapati Sambhajnagar, May 15 (UNI) : The Marathwada region's potable water shortage is escalating due to insufficient rainfall and the drying up of water resources. Currently, 1691 water tankers are providing water to 1149 affected villages and 441 hamlets.

An official report released by the Divisional Commissioner office here on Wednesday stated that up to May 12, a total 1691 water tankers were engaged in the service to supply water in thirsty villages in seven districts.

Out of 1691 tankers, 656 are serving 405 villages and 61 hamlets in Chhatrapati Sambhajnagar district, while 475 are supplying water to 324 villages and 74 hamlets in Jalna district.

382 water tankers serve 308 villages and 282 hamlets in Beed, whereas 129 tankers are supplying water to 37 villages in Dharsiv, 21 tankers in 18 villages and 4 hamlets in Latur district, 16 tankers in 3 villages and 13 hamlets in Nanded district, and 12 in 8 villages and 7 hamlets in Parbhani district. However, no tankers are currently in the Hingoli district of the region, indicating a lack of water supply. Meanwhile, authorities have acquired a total of 2607 wells, so far to fill up the tankers with drinking water purpose, the report added.

Gwalior 'Rajmata' Madhavi Raje passes away

Gwalior, May 15 (UNI) : Madhavi Raje Scindia (70), the queen mother of the Gwalior royal family and mother of Union Minister Jyotiradiya Scindia, passed away on Wednesday.

Her last rites will be performed with traditional rituals in Gwalior Thursday afternoon. Sources close to the Scindia family informed that she breathed her last at 9.28 am at the All India Institute of Medical Sciences (AIIMS), New Delhi. Her family members were with her during that time.

Scindia, wife of former Union Minister Madhav Rao Scindia, was unwell for the last three months and was undergoing treatment at AIIMS for about two months. Her condition was critical over the last two weeks and she was on ventilator.

She belonged to the Rana dynasty of Nepal. The head of this dynasty was Juddha Shumsher Jung Bahadur Rana, who was also the Prime Minister of Nepal. She was married to the then Maharaja of Gwalior Madhav Rao Scindia on May 8, 1966. Before becoming the daughter-in-law of the Scindia royal family, her name was Kiran Raj Lakshmi.
